The following resolution was offered by Susan Stanczyk, seconded by Janice Herzog, to wit:

RESOLUTION AUTHORIZING ISSUANCE OF A REQUEST FOR PROPOSALS FOR PROFESSIONAL GOVERNMENT AND BUSINESS DEVELOPMENT CONSULTING SERVICES

WHEREAS, the Agency is authorized and empowered by the provisions of Chapter 1030 of the 1969 Laws of New York, constituting Title 1 of Article 18-A of the General Municipal Law, Chapter 24 of the Consolidated Laws of New York, as amended (the “Enabling Act”), Chapter 435 of the Laws of 1970 of the State of New York and Chapter 676 of the Laws of 1975 of the State of New York, as amended, constituting Section 895 of said General Municipal Law (said Chapter and the Enabling Act being hereinafter collectively referred to as the “Act”) to promote, develop, encourage and assist in the acquiring, constructing, reconstructing, improving, maintaining, equipping and furnishing of manufacturing, warehousing, research, commercial and industrial facilities, among others, for the purpose of promoting, attracting and developing economically sound commerce and industry to advance the job opportunities, health, general prosperity and economic welfare of the people of the State of New York (the “State”), to improve their prosperity and standard of living, and to prevent unemployment and economic deterioration; and

WHEREAS, the Agency desires to engage qualified contractors to provide professional government services to the Agency, including but not limited to consulting services regarding government policy and legislation in the State and working with government agencies, private sector, business and economic development in the State (collectively, the “Government Consulting Services”); and

WHEREAS, the Agency desires to have the Executive Director prepare and distribute a Request for Proposals for Professional Services (the "RFP") pursuant to its Procurement Policy to invite proposals from qualified contractors to provide the Government Consulting Services;

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE ONONDAGA COUNTY INDUSTRIAL DEVELOPMENT AGENCY AS FOLLOWS:

Section 1. The Agency hereby authorizes and directs the Executive Director: (i) to prepare the RFP, (ii) to distribute the RFP, (iii) to review responses to the RFP, (iv) to coordinate with those entities submitting responses to the RFP for such follow-up information as the Executive Director deems necessary or appropriate, and (v) to provide responses to the RFP to the Agency for the Agency's review and consideration at a future meeting. All such action are to be consistent in all cases with the Procurement Policy of the Agency.

Section 2. This Resolution shall take effect immediately.
