## 1. Dig Safely New York, Inc.

Dig Safely New York, Inc. is requesting bonding assistance up to a \$6,000,000 (six million dollars) for the cost of a new project. Costs include closing costs and funding a debt service reserve fund, capitalized interest, and other costs incidental to the issuance of bonds.

The project will include the construction of a new facility on a four-acre parcel, already owned by Dig Safely New York, Inc., at 6706 Collamer Road, East Syracuse, NY 13057. This new facility will consist of an 8,500 sq. ft. state –of-the-art year round indoor training and educational center as well as a 13,000 sq. ft. call center. This new facility will accommodate the current and future growth of the organization.

**Board Action Requested:** An official intent resolution for the financing of up to \$6,000,000 (Six million dollars) in tax exempt bonds for the Dig Safely New York, Inc. project.
