REVIEW OF CRT 2020 AUDIT PROPOSALS

Robert Petrovich stated staff sends out RFPs every 3 years. He stated this was done in the Fall so in 2021 we will have firms available to us for our financial and legal needs as we navigate the business of CRT on a bimonthly basis. He stated we received responses from Bonadio Group and Grossman St. Amour. He stated staff's recommendation is to award contracts to both firms and then in January at the organizational meeting staff will make a recommendation to name primary audit council and conflict audit counsel. He stated both firms are quality firms and can do work for CRT in this particular area.

Upon a motion by Leslie Garcea, seconded by Regina McArthur, the CRT Board approved a resolution to award contracts to Bonadio Group and Grossman St. Amour for audit services. Motion was carried unanimously.

REVIEW OF CRT 2020 LEGAL PROPOSALS

Robert Petrovich stated an RFP was sent out for legal services as we do every 3 years. He stated at the organizational meeting in January there will be the selection of primary CRT counsel and then conflict counsel. He stated at this point all the firms that have submitted can adequately

represent CRT. He stated staff's recommendation to the Board is to award contracts to all of the firms then at the organizational meeting in January nominate primary counsel and the rest of the firms would be conflict counsel as the need arises through the course of the normal business.
