### CULTURAL AND RECREATIONAL EVENT - MOVIE NIGHT AT THE AMPHITHEATER

Julie Cerio stated there is a proposal to enter into a contract with Galaxy Communications to provide management and promotion to a free 3 night event to the public featuring 2 full length movies each night. She stated one will be for a younger crowd and one for an older crowd but there is no age requirement. She stated Galaxy Communications is asking CRT to enter into a sole source contract with them for \$15,000 to hold this event. She stated Chris Andreucci as our counsel feels this fits into our corporate purpose because one of our purposes is to encourage and create an innovative use of public and private resources in order to preserve and protect the cultural resources of the County.

Greg Lancette asked if there will be one screen on stage or multiple. Bill Lansley stated they will have 3 LCD screens, 2 on the sides of the stage and he believes they will have a 100 foot inflatable movie screen on stage.

Greg Lancette asked who selected the movies. Bill Lansley stated it was a group effort.

Upon a motion by Greg Lancette, seconded by Dennis Duval, the CRT Board approved a resolution of the Board authorizing the execution and delivery of the contract with Galaxy Communications (the vendor) consistent with the terms described and authorizing in accordance with the procurement policy, the procurement of this serve as a sole source contract. Motion was carried unanimously.
