The following resolution was offered by Janice Herzog, seconded by Fanny Villarreal, to wit:

**RESOLUTION RATIFYING THE APPROVING RESOLUTIONS
PREVIOUSLY ADOPTED WITH RESPECT TO A PROJECT AFTER THE
SALE OF THE MEMBERSHIP INTERESTS IN THE COMPANY**

WHEREAS, Onondaga County Industrial Development Agency (the "Agency") is authorized and empowered by the provisions of Chapter 1030 of the 1969 Laws of New York, constituting Title 1 of Article 18-A of the General Municipal Law, Chapter 24 of the Consolidated Laws of New York, as amended (the "Enabling Act") and Chapter 435 of the Laws of 1970 of the State of New York and Chapter 676 of the Laws of 1975, as amended, constituting Section 895 of said General Municipal Law (said Chapter and the Enabling Act being hereinafter collectively referred to as the "Act") to promote, develop, encourage and assist in the acquiring, constructing, reconstructing, improving, maintaining, equipping and furnishing of manufacturing, warehousing, research, commercial and industrial facilities, among others, for the purpose of promoting, attracting and developing economically sound commerce and industry to advance the job opportunities, health, general prosperity and economic welfare of the people of the State of New York (the "State"), to improve their prosperity and standard of living, and to prevent unemployment and economic deterioration; and

WHEREAS, to accomplish its stated purposes, the Agency is authorized and empowered under the Act to acquire, construct, reconstruct and install one or more "projects" (as defined in the Act), or to cause said projects to be acquired, constructed, reconstructed and installed, and to convey said projects or to lease said projects with the obligation to purchase; and

WHEREAS, on or about November 8, 2019, the Agency received an application (the "Application") from Abundant Solar Power (SK1) LLC, a New York limited liability company (the "Company"), to undertake a project (the "Project") on behalf of itself and entities formed or to be formed on its behalf, said Project consisting of the following: (A)(1) the acquisition of a leasehold interest in a portion of an approximately 72 acre parcel of land located at 1676 Old Seneca Turnpike (tax map no. 030-.02-04.0) in the Town of Skaneateles, Onondaga County, New York (the "Land"); (2) the construction on the Land of an approximately 7 acre solar power electric generating photo-voltaic plant; (the "Facility"); and (3) the acquisition and installation therein and thereon of related fixtures, machinery, equipment and other tangible personal property (collectively, the "Equipment") (the Land, the Facility and the Equipment being collectively referred to as the "Project Facility"); (B) the granting of certain "financial assistance" (within the meaning of Section 854(14) of the Act) with respect to the foregoing, including potential exemptions from certain sales and use taxes, real property taxes, real estate transfer taxes and mortgage recording taxes (subject to certain statutory limitations) (collectively, the "Original Financial Assistance"); and (C) the lease (with an obligation to purchase) or sale of the Project Facility to the Company or such other person as may be designated by the Company and agreed upon by the Agency; and

WHEREAS, in the Application the Company listed its sole shareholder as Abundant Solar Power Inc. (the "Original Membership Owner"); and

WHEREAS, the Agency adopted a public hearing resolution on November 19, 2019 and conducted the public hearing on December 3, 2019; and

WHEREAS, the Agency conducted an environmental review of the project pursuant to the State Environmental Quality Review Act ("SEQRA") and adopted a resolution on December 10, 2019 issuing a negative declaration for the Project upon determining that it would not result in any significant adverse environmental impacts; and

WHEREAS, the Agency adopted an approving resolution, authorizing the Project at its December 10, 2019 meeting (the "Initial Approving Resolution"); and

WHEREAS, the Agency conducted a second public hearing on January 6, 2020 to authorize additional sales and use tax exemption benefits; and

WHEREAS, the Agency adopted an amended approving resolution, authorizing the Project with the additional sales and use tax exemption benefits at its January 14, 2020 meeting (the "Amended Approving Resolution" and, together with the Initial Approving Resolution, the "Approving Resolutions"); and

WHEREAS, the Agency and the Company have not closed on the straight-lease transaction associated with the Project and approved by the Agency in the Approving Resolutions; and

WHEREAS, on or about March 6, 2020, the Agency received notice from the Company that, pursuant to a certain Assignment of Interest Agreement between the Original Membership Owner and Solarize NY Holdings, LLC (the "New Membership Owner"), the Original Membership Owner sold and the New Membership Owner purchased 100% of the membership interests in the Company; and

WHEREAS, the Company has submitted and the Agency has reviewed the organizational documents of the New Membership Owner and the Company has answered the Agency's questions regarding the New Membership Owner and the impact of the change in ownership on the Project and the Financial Assistance previously approved by the Agency; and

WHEREAS, in light of the change in the ownership of the membership interest in the Company, the Agency desires to ratify the Approving Resolutions, including its approval of the Project and the grant of the Financial Assistance to the Company; and

WHEREAS, the change in the ownership of the membership interest in the Company is not material, will not result in any additional environmental impacts that were not addressed as part of the original SEQRA determination, and does not require that the Agency alter or amend its prior negative declaration for the Project, which is hereby ratified and reaffirmed.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE ONONDAGA COUNTY INDUSTRIAL DEVELOPMENT AGENCY AS FOLLOWS:

Section 1. Based upon the representations made by the Company to the Agency, the Agency makes the following findings and determinations:

- (A) The Project constitutes a "project" within the meaning of the Act; and
- (B) The change in ownership of the membership interests in the Company does not constitute a significant change from the original Project that was reviewed under SEQRA and therefore no further or additional review under SEQRA is required; and
- (C) The change in ownership of the membership interests in the Company is not a material change and does not require a change in the Financial Assistance previously approved by the Agency.

Section 2. The Agency hereby ratifies the Approving Resolutions and reaffirms the approval of the grant of the Financial Assistance to the Company.

Section 3. The Chairperson and the Executive Director of the Agency are hereby authorized and directed to distribute copies of this Resolution to the Company and to do such further things or perform such acts as may be necessary or convenient to implement the provisions of this Resolution.

Section 4. This Resolution shall take effect immediately upon adoption.


