Electric and Natural Gas Utilities Proposed District East Development Town of DeWitt, New York

The District East Redevelopment will contain a mix of uses, including medical office, retail, educational, entertainment and residential. Based on these uses, Argus Engineering, PLLC estimated the annual electric and natural gas consumption by utilizing the most current data published by the US Energy Information Administration. The annual electricity consumption in kWh is projected to be 18,976,514. The annual natural gas consumption in CF is projected to be 51,126,272. The natural gas consumption was broken down by hour by use at the request of the James Williamson, Lead Supervisor at National Grid Upstate NY Natural Gas Department.

Copies of the usage projections were forwarded to National Grid and the electric and natural gas departments at National Grid Upstate NY issued will serve letters for their respective utilities.
