GSPP Sentinel Heights Road, LLC, (the "Company") filed an application with the Agency requesting that the Agency consider undertaking a project (the "Project") consisting of: (1) the acquisition of a leasehold interest in a portion of an approximately 94 acre parcel of land located on Sentinel Heights Road (tax map no. 025.-03-02.2) in the Town of Lafayette, Onondaga County, New York (the "Land"); (2) the construction on the Land of an approximately 18 acre solar power electric generating photo-voltaic plant; (the "Facility"); and (3) the acquisition and installation therein and thereon of related fixtures, machinery, equipment and other tangible personal property (collectively, the "Equipment") (the Land, the Facility and the Equipment being collectively referred to as the "Project Facility".

The Company will be the initial owner and/or operator of the Project Facility.

The Agency has not made a decision with respect to the undertaking of the Project or the granting of the financial assistance.
