**RESOLUTION DETERMINING THAT ACTION TO UNDERTAKE A COMMERCIAL
PROJECT FOR SPECIALISTS' ONE-DAY SURGERY, LLC IS AN UNLISTED
ACTION AND NO FURTHER ENVIRONMENTAL REVIEW IS REQUIRED UNDER
SEQRA**

WHEREAS, the Onondaga County Industrial Development Agency (the "Agency") is authorized and empowered by Title 1 of Article 18-A of the General Municipal Law, Chapter 435 of the 1970 Laws of New York, and Chapter 676 of the 1975 Laws of New York, as amended, constituting Section 895 of said General Municipal Law (said Chapter and the Enabling Act being hereinafter collectively referred to as the "Act") to promote, develop, encourage and assist in the acquiring, constructing, reconstructing, improving, maintaining, equipping and furnishing of industrial, manufacturing, warehousing, commercial, research and recreation facilities, including industrial pollution control facilities, educational or cultural facilities, railroad facilities, horse racing facilities and continuing care retirement communities, among others, for the purpose of promoting, attracting, encouraging and developing recreation, and economically sound commerce and industry to advance the job opportunities, health, general prosperity and economic welfare of the people of the State of New York and to improve their recreation opportunities, prosperity and economic welfare of the people of the State of New York and to improve their recreation opportunities, prosperity and standard of living, and to prevent unemployment and economic deterioration; and

WHEREAS, to accomplish its stated purposes, the Agency is authorized and empowered under the Act to acquire, construct, reconstruct, improve, maintain, equip or furnish one or more "projects" (as defined in the Act"); to sell, convey, mortgage, lease, pledge, exchange or otherwise dispose of said projects; and to issue bonds and provide for the rights of the holders thereof; and

WHEREAS, Specialists' One-Day Surgery, LLC (the "Company") has presented an application (the "Application") to the Agency, a copy of which was presented at this meeting and copies of which are on file at the office of the agency, requesting the Agency consider undertaking a project (the "Project") consisting of the following: construction and equipping of approximately 47,713 square feet of space containing eight Class C operating rooms, a waiting area, prep/holding area, extended recovery area and ancillary facilities for the Ambulatory Surgery Center and the renovation, reconfiguration and downsizing of the Specialists' One-Day Surgery Center located at Airport Business Park, 5801 East Taft Road located in the Town of Salina, County of Onondaga; and

WHEREAS, the Agency has given due consideration to the Application and to representations made by the Company that (A) the granting by the Agency of the Financial Assistance with respect to the Project will be an inducement to the Company to undertake the Project in Onondaga County, New York; and (B) the completion of the Project will not result in the removal of a facility or a plant of the Project occupant from one part of the State of New York to another area of the State of New York or in the abandonment of one or more plants or facilities of the Project occupant located within the State of New York; and

WHEREAS, in compliance with the provisions of Section 859-a of the Act and Section 147(f) of the Internal Revenue Code of 1986, as amended (the “Code”), the Assistant Secretary of the Agency (A) caused notice of a public hearing (the “Public Hearing”) of the Agency to hear all persons interested in the Project and the Financial Assistance being contemplated by the Agency with respect to the Project to be mailed to the chief executive officer of the county and of each city, town, village and school district in which the Project is to be located, (B) caused notice of the Public Hearing to be published in The Post-Standard, a newspaper of general circulation available to the residents of the Town of Cicero (C) conducted the Public Hearing at the Town of Cicero Town Hall located at 5801 East Taft Road, North Syracuse, in the Town of Cicero, Onondaga County, New York, and (D) prepared a report of the Public Hearing which fairly summarized the views presented at the Public Hearing and distributed same to the members of the Agency; and

WHEREAS, the Agency is a local agency pursuant to the New York State Environmental Quality Review Act (“SEQRA”), ECL Section 8-0101, *et seq.*, and implementing regulations, 6 NYCRR Part 617 (the “Regulations”); and

WHEREAS, undertaking the Project is an Action as defined by SEQRA; and

WHEREAS, a long-form Environmental Assessment Form (“EAF”), was submitted to the Town of Cicero to facilitate a review of the potential environmental impacts of the Project; and

WHEREAS, the Town has preliminarily determined that the Action is an Unlisted Action, as that term is defined in the Regulations, and that no environmental review is required under SEQRA; and

WHEREAS, the Town has considered the Project and the EAF, together with the Agency’s knowledge of the area surrounding the Project, and such further investigation of the Project and its potential environmental effects as the Town has deemed appropriate; and

WHEREAS, the Agency has reviewed the classifications of actions contained in the Regulations, and has compared the effects of the Project to the provisions of 6 NYCRR Part 617 which relate to the classification of actions under SEQRA; and

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE ONONDAGA COUNTY INDUSTRIAL DEVELOPMENT AGENCY AS FOLLOWS:

- Section 1. The Project is an Unlisted Action pursuant to SEQRA.
- Section 2. The Agency has adopted the findings of the Lead Agency, the Town of Cicero.
- Section 3. The Project will result in no significant adverse environmental impact.

Section 4. The Negative Declaration shall be filed at the Agency as required by 6 NYCRR Section 617.12(b)(2).

Section 5. This resolution shall take effect immediately.
